- On the advice from Paul Ryan, Solicitor, we need to get the Verizon phone and internet service for Haneyville Fire Company taken out of the Township's name and put into their own name so that they have access to their own account. This was discussed in a meeting with John, new Fire Chief and he agreed to have Lori, Secretary/Treasurer for fire company work with Shelly on transferring service into their name.
